Call Me Captain

Leaving the weirdness of wind turbines behind us, we prepared for our entrance to the Erie Canal System. This really meant making sure we found the entrance and did not remain long on the Niagara River. The downstream current might easily overpower the 200hp turbodiesel and, well, I did not want to be the first Mainship to go over the Falls. And yes, we did plan this out ahead...by about 30 minutes.

The Western Erie Canal begins at Tonawanda on the Niagara River, halfway between Buffalo and Niagara Falls and continues east to the Hudson River north of Albany. That's a lot of real estate! The Black Rock Canal connects the Erie Canal through the Niagara River with Lake Erie and Buffalo NY, the western terminus of the original Erie Canal. This was the first lock and was a safe path to avoid part of the Niagara River and the Peace Bridge.

Approaching this first lock the crew mutinied. "Here, you drive Captain Glenn!" Up to this point, I was really just part of the crew. I witnessed their conspiratorial huddle prior to handing me absolute control over my new-to-me domain. "Ya gotta learn some time." I'm sure my

pallor was not obvious in the glorious sun of this 2nd day. "Tell us what to do!" And I did. Get on the radio and call the lockmaster. Uh no, that's your job, Captain. Oh. OK, George, go forward and Mark, you stay aft. Put on your gloves and grab a pole. All of this maneuvering about the edges of the boat, precariously close to slimy walls, and we never once put on a life vest.

I made the call. The lock was waiting as we were the only vessel passing through. I can't recall all the details. I was observing myself from afar. As if everyone was watching. It was my first command moment. This is not my natural state. The protocol for calling a lock is just about anything you say on channel 16. Then you wait for a green light and proceed part way into the lock, find a good spot where the hanging lines are the right distance apart for fore and aft control, and then wait some more. The challenge was getting the boat close to the wall, not hitting reverse by accident or accelerating uncontrollably. We were lifted (or dropped) about 14 feet, the gates opened and we headed downstream to Tonawanda.

No meeting therefore, no speaker in July. I continue to make calls to lost former members.

Our next course will be Seamanship starting the last week of September.

Educational tip of the month: ON WIND DIRECTION AND SPEED. We all know that the wind that affects the boat is a combination of the true wind and the boat wind, which is the speed of the boat through the water. The resultant wind is called the apparent wind, the wind that affects the boat, but do not be misled. It may be called apparent, but it is the real wind as far as the balance of the vessel is concerned, the size of the waves to be expected, fuel consumption if under power and the amount of canvas carried if sailing, etc.

Here are some things to keep in mind about the apparent wind:

The apparent wind is always forward of the true wind unless the true wind is coming from dead ahead or dead astern. Put another way, the wind you feel on the boat if it's coming from the side is forward of where the true wind is coming from.

As the true wind comes aft, the apparent wind lessens. This is why on a sailboat it feels hotter and slower going down wind. And why when under power as the apparent wind speed approaches zero (you're going downwind at roughly the speed of the wind), you're keeping your exhaust fumes with you unless you outrun the wind astern and thus create enough boat wind to blow the fumes away. But near zero of apparent wind you're taking on fumes.

Conversely, when the true wind is forward of the beam, the apparent wind, the wind you feel, the wind that's affecting the boat is greater than the true wind speed. So when you see white caps and figure 10 knots of wind and you're heading into it, you've got more wind than 10 knots. How much more depends on the speed of your boat and the angle of the boat to the wind. Keep this in mind when you're checking wind predictions before going out.

SECRETARY'S REPORT



The EPA, Proposes Increasing the Percentage of Corn Based Ethanol into our Fuel Supply: Based on the recent EPA announcement, they will increase the 2017 Renewable Fuel Standard (RFS) increasing the blend requirements to 14.8 Billion gallons of corn ethanol with gasoline. The National Marine Manufacturers Association (NMMA), Congressman Goodlatte, other members of Congress, the National Boating Federation and the Environmental Working Group, are all adamantly opposed to any increase of corn ethanol into our fuel supply. Congressman Goodlatte, along with many cosponsors, introduced two bills, the bipartisan RFS Reform Act, and another to eliminate the RFS entirely. As stated by the NMMA "The proposal increases the need for higher blends of ethanol to record levels, pushing further past the E10 blend wall, forcing an increase of 700 million gallons and endangering more consumers, including recreational boaters." According to the EPA, the 700M gallon increase is based on increasing Renewable Fuel Volume from 18.1 billion gallons in 2016 to 18.8 billion gallons in 2017. How much this increases the PER-**CENTAGE** of ethanol in gasoline is no doubt beyond E15, the total percentage we do not know. One thing we do know, based on several engineering studies and Congressional testimony before the House Subcommittee on Energy and Environment, more ethanol will cause severe damage to engine components and increase exhaust emissions, reinforcing the recreational boating community's concern that E15 and greater, is not a suitable fuel for marine engines.

once again failed to meet basic marketplace realities and represent another step backwards with regard to this unworkable mandate. By increasing the required amount of ethanol to record-levels in 2017, the EPA is not only denying the choice of consumers at the pump, but also putting the public at risk of misfueling. This announcement will only cause headaches for consumers who will no longer be able to obtain the low-ethanol and ethanolfree fuel blends they seek for their boats. The mandate further promotes the expansion of E15—a known harmful fuel to marine and off road engines, and still does not include any plans for the widespread public outreach efforts needed to educate consumers on the problems they may face including engine damage, voided warranties and costly repairs. As we've said before, the RFS is a broken law which sets unrealistic fuel mandates. And as we have done in the past, we again urge Congress to act swiftly by reforming the RFS in order to protect our industry and the others negatively affected by this decision. NMMA will be involved in the final rule making process, and looks forward to working with the EPA, our members and other stakeholders to deliver a common-sense rule that keeps the 88 million boaters safe on the water.

Please contact your Congressional representatives and let them know your position on this matter.

NMMA's Response to the RFS Ruling: The 2017 RFS proposed ethanol volumes released by the EPA

No More Flares—Sirius Signal Light

SIRIUS SOS-C-1001 electronic distress light is relatively new on the market. It is a product of Weems and Plath. This light is powered by C batteries and is acceptable to use this light as a nighttime visual distress signal. A daytime (orange flag) is included when you purchase the SIRIUS SOS-C-1001. You must have both the distress light and flag onboard to comply with Coast Guard regulations regarding daytime/nighttime signaling requirements. These two items can replace your flares.

To be acceptable, ALL electronic visual signals must be legibly and indelibly marked with the statement, "Night Visual distress Signal for Boats Complies with U.S. Coast Guard Requirements in 46 CFR 161.013-3". The manufacturer's name, replacement battery type and lamp size must also be on the distress light.

The selling price is normally \$99. West Marine has had it on sale for \$89. You can order directly from Weems and Plath and if you mention you are a member of Dundalk Sail & Power Squadron you can get it for around \$75.


